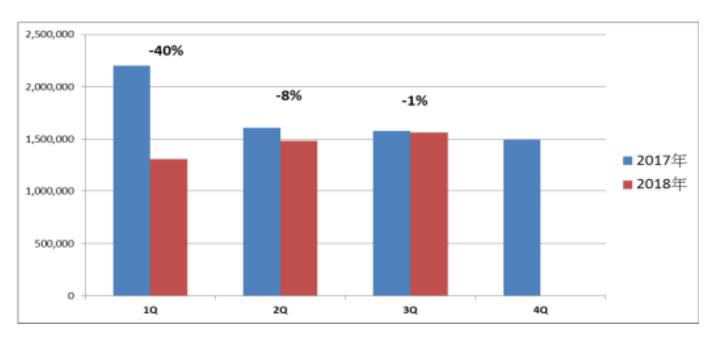

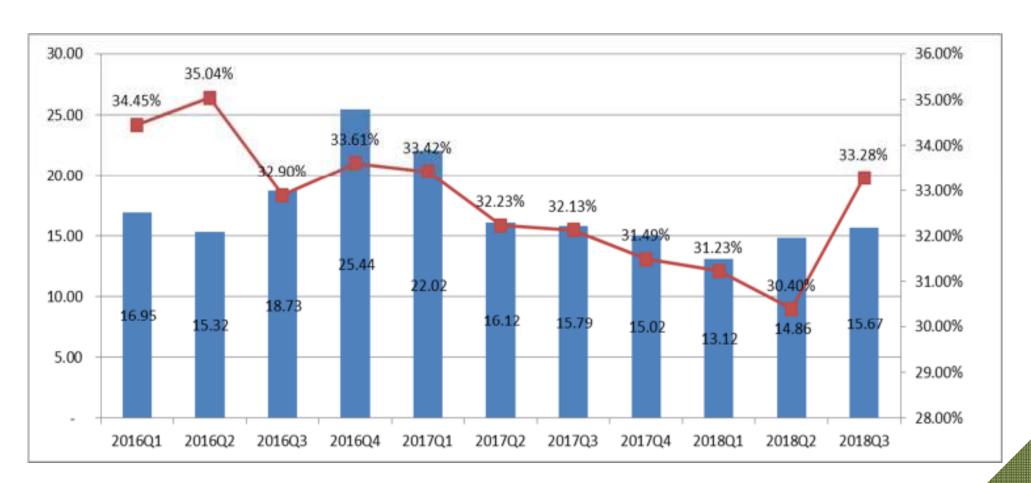

Quarterly Revenue & Gross Margin Amount: NT\$ 100 mio

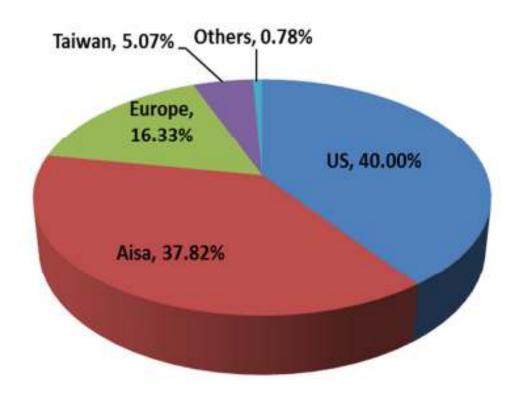


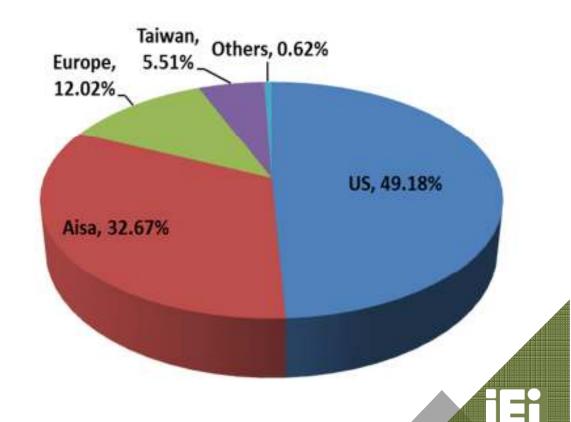


Revenue by Client

2018 Q1~Q3

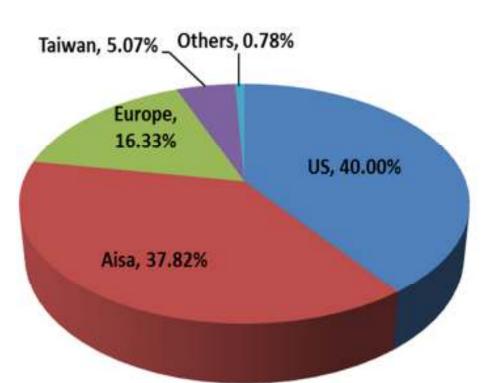

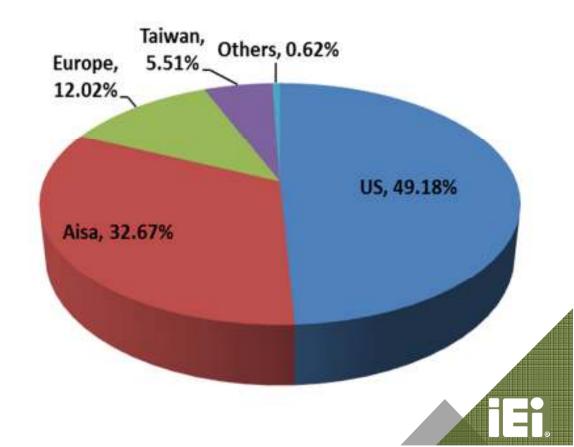


Revenue by Client

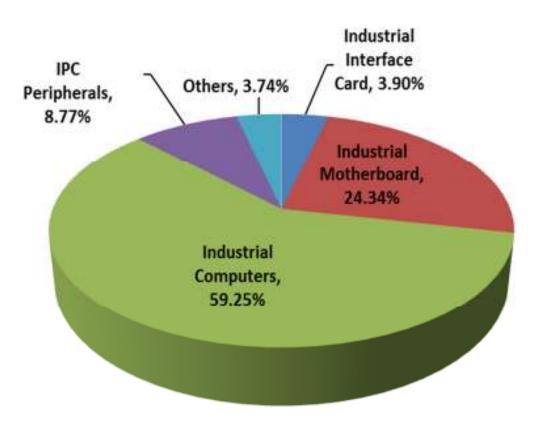
